What is CIP Cleaner?

A heavy duty caustic cleaner for use in CIP systems, and soak tanks to remove heavy build up from proteins, fats, oils, and grease. Excellent for removing carbon from non gluminum surfaces, USDA applicable.

Directions:

For institutional or commercial use.

Before use, read product label and Safety Data Sheet.

Cover or remove all food products from area to be cleaned. Remove gross accumulation of meat particles, soil and other waste materials from surfaces and equipment.

Dilute product 1/2 oz to 4oz per gallon of water. Circulate through system until desired cleaning has been achieved. Flush system then rinse thoroughly with potable water.

For boil outs dilute 2 to 8 ounces per gallon depending on build up. Scrub with a brush if needed.

Do not use on aluminum, tin or zinc-plated surfaces. Pitting or surface deterioration may result.

Prevention:

Do not eat, drink, or smoke while using this product.

Avoid breathing fumes, mist and overspray as much as possible. Use only in well ventilated areas.

Eyes: Wear safety glasses when handling product. Skin: Wear appropriate gloves to prevent skin exposure. **Clothing:** Wear appropriate protective clothing to prevent skin exposure.

Respirators: Follow the OSHA respirator regulations if exposure limits are exceeded or if irritation or other symptoms are experienced.

Precautionary Statements (First Aid):

Eyes: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Remove contact lenses if present and easy to do. Get medical attention immediately if irritation persists.

Skin: Immediately flush skin with plenty of water for at least 15 minutes while removing any contaminated clothing and shoes. Discard contaminated clothing in a manner which limits further exposure, making sure to wash before reuse. Contact a physician immediately if irritation persists.

Ingestion: Do not induce vomiting. If victim is conscious and alert, give 2-4 cups of water. Never give anything by mouth to an unconscious person. Get medical attention immediately.

Inhalation: Remove from exposure and move to fresh air immediately and keep comfortable for breathing. If breathing is difficult, give oxygen. If breathing has ceased apply artificial respiration using oxygen and a suitable mechanical device such as a bag and a mask. Get medical attention immediately if irritation persists.

Notes to Physician: Treat symptomatically and supportively. Consult a doctor and/or the nearest Poison Con-

trol Centre for all exposures.
