**Dilute concentrate 10:1 to clean: Lipstick Stains • Greasy Concrete • Ink Stains • Electric Motors • Gymnasiums • Brick Grills • Heavy Wax Build-Up • Motor Shells • Air Conditioning Units • Printing Presses • Whitewall Tires**
