On vertical surfaces be sure to apply solution from bottom up. Detail clean from the bottom up and wipe dry form the top down. For Cleaning Vinyl: simply spray AGP50 as is or with up to 10 to 15 parts water onto surface to be cleaned. Starting at the vertical surfaces first, then moving to the horizontal. Be certain to prevent AGP50 from running onto the adjacent paint. Allow the solution to stand a few minutes, then using a soft bristle brush, sponge or rag, scrub in a circular motion. Once all soils have been loosened, rinse with water from the top down with a soft cloth then with a dry cloth.

For Oil Removal, spray as is onto the oil to be removed. Agitate the mixture until tall the oils is emulsified for removal. It may then be rinsed.
