

### Potential Health Effects

INHALATION: Inhalation of dust may cause irritation of the upper respiratory tract with sore throat, coughing and shortness of breath. Upon contact with most mucous membranes, sodium metasilcate is highly alkaline and may cause corrosive damage. May cause severe irritation of the respiratory tract with coughing, choking, pain and possibly burns of the mucous membranes. In some cases, pulmonary edema and or pneumonia may develop either immediately or more often within 72 hours. The symptoms may include tightness in the chest, dysponea, frothy sputum, cyanosis, and dizziness. Physical findings may include moist rales, low blood pressure and high pulse pressure.

INGESTION: Swallowing can cause severe burns of the mouth, throat, and stomach. Can cause sore throat, vomiting, diarrhea. Edema of the epiglottis and shock may occur.

SKIN CONTACT: Corrosive. Symptoms of redness, pain, and severe burn can occur.

EYE CONTACT: Dust or mist may cause severe irritation, pain and corneal burns (possibly leading to blindness). The full extent of the injury may not be immediately apparent.

CHRONIC EXPOSURE: No information found.

**ECOLOGICAL HAZARDS:** Keep out of water supplies and sewers. This material is alkaline and may raise the pH of surface waters. This material has exhibited moderate toxicity to aquatic organisms.

### 4. First Aid Measures

Eyes	Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Remove contact lenses if present and easy to do. Washing eyes within several seconds is essential to achieve maximum effectiveness. Get medical attention immediately.	
Skin	Immediately flush skin with plenty of water for at least 15 minutes while removing any contaminated clothing and shoes. Discard contaminated clothing in a manner which limits further exposure, making sure to wash before reuse. Contact a physician immediately if irritation persists.	
Ingestion	Do not induce vomiting. If victim is conscious and alert, give 2-4 cups of water. Never give anything by mouth to an unconscious person. Get medical attention immediately.	
Inhalation	Remove from exposure and move to fresh air immediately and keep comfortable for breathing. If breathing is difficult, give oxygen. Call a doctor or poison control center if symptoms persist. If breathing has ceased apply artificial respiration using oxygen and a suitable mechanical device such as a bag and a mask. Call a doctor or poison control immediately.

# 5. Fire Fighting Measures

# 6. Accidental Release Measures

**Protective Measures:** Eliminate all sources of ignition in the vicinity of the spill or released vapor. If this material is released into the work area, evacuate the area immediately. Monitor area with combustible gas indicator. Wear appropriate personal protective equipment when cleaning up spills. Refer to Section 8. Eliminate potential sources of ignition. Handling equipment must be bonded and grounded to prevent sparking.

**Spill Management:** Stop the source of the release if you can do it without risk. Contain release to prevent further contamination of soil, surface water or groundwater. Clean up spill as soon as possible, observing precautions in Exposure Controls/Personal Protection. Use appropriate techniques such as applying non-combustible sorbent materials or pumping. All equipment used when handling the product must be grounded. A vapor suppressing foam may be used to reduce vapors. Use clean non-sparking tools to collect absorbed material. Where feasible and appropriate, remove contaminated soil. Place contaminated materials in disposable containers and dispose of in a manner consistent with applicable regulations.

# 7. Handling and Storage

**General Storage Information:** Container is not designed to contain pressure. Do not use pressure to empty container or it may rupture with explosive force. Empty containers retain product residue (solid, liquid, and/or vapor) and can be dangerous. Do not pressurize, cut, weld, braze, solder, drill, grind, or expose such containers to heat, flame, sparks, static electricity, or other sources of ignition. They may explode and cause injury or death. Empty containers should be completely drained, properly closed, and promptly returned to a drum reconditioner, or disposed of properly. 
