### DESCRIPTION:

PFG-5 is a low foaming, heavy duty, powdered chlorinated detergent. PFG-5 is used for cleaning tough fats, grease, protein, stain removal, and for removing odors. PFG-5 is excellent for use in C.I.P. procedures and to promote free-rinsing. USDA applicable.

### DIRECTIONS:

**For Use In Steam Cleaner Or High-Pressure Washer:** Use 2 to 4 ounces per gallon of hot water and spray on soiled areas. Rinse thoroughly.

**For Use In Solution Without A Steam Machine:** Use 4 to 6 ounces per gallon of hot water and wash down equipment with a brush. Rinse thoroughly.

**For Use In Processing Vats:** Make solution of approximately 8 ounces per gallon of hot water and wash down with a brush. Rinse thoroughly.

**C.I.P. Procedures:** Flush system with cold water. Prepare a solution of 4 ounces (1/4 lb.) per gallon of water. Circulate through system until soils are loosened and/or removed as determined by inspection. Drain and rinse thoroughly with potable hot water. For use on ferrous metals only. Do Not use on galvanized metals, aluminum, or other alkali-sensitive surfaces, as damage may occur. Avoid contact with painted surfaces.

### CAUTION:

It is recommended that protective gloves and safety glasses be worn when using this product. Refer to MSDS for additional safety information and precautions.

### EXPOSURE:

This product may cause moderate to severe irritation and possible tissue damage to eyes depending on exposure. Nausea, vomiting and diarrhea may occur upon ingestion. Prolonged skin contact may cause moderate irritation and dermatitis.
